It is understood the materials requested in the attached material list shall be delivered to the designated area no later than 30 days of written notification of award.

Respondents may not withdraw their written response for a period of thirty days, excluding Saturdays, Sundays and legal holidays from the date written responses are due. It is anticipated that the accepted low price proposal will be notified no later than 5 business days from the date written responses are due.

Payments and/or partial payment for materials delivered and accepted at the site will be made in accordance with the Town payment policy. Approved invoices are paid on a bi-weekly payment schedule, every other Thursday. Checks are mailed or can be picked up at Town Hall with prior notification. The Contractor is responsible for obtaining all applicable insurance and/or bonds. The Town of Manchester by the Sea is tax exempt. A tax exempt form will be made available upon request.

The Town will award the Contract based on the lowest price proposal and reserves the right to waive any informality in or to reject any or all written responses if deemed to be in its best interest.
