APPENDIX A - ROADWAY REHABILITATION DESCRIPTIONS AND CONSTRUCTION DETAILS

All prospective Bidders are hereby notified to a clarification of the proposed pavement treatment.

Moses Hill Road and Rockwood Heights Road existing pavement surfaces are proposed to be excavated and removed (Item 120.1 Unclassified Excavation). The existing subgrade is to be shaped, graded and compacted (Item 170. Fine Grading and Compacting) as required by the Engineer. Driveway aprons are to be reconstructed (Item 703. Hot Mix Asphalt Driveway) to meet the proposed edge of roadway as required by the Engineer. Also, hot mix asphalt driveways shall extend approximately 5'+/- into and meet the existing driveway surface.

Typical pavement notes for hot mix asphalt driveway are as follows:

Surface: 1 ½" Superpave Surface Course – 9.5 (SSC-9.5)

Intermediate: 1 ½" Superpave Surface Course – 9.5 (SSC-9.5)

Subbase: N/A Existing subbase shall be retained.

Moses Hill Road existing pavement depths vary from 2.0" to 6.7" (average 4.3").

Rockwood Heights Road existing pavement depths vary from 1.5" to 4.6" (average 2.8").

As approved by the Town, Contractors may choose, for their convenience, to reclaim the existing roadway pavement in lieu of removal of the existing pavement (item 120.1 Unclassified Excavation). Contractors choosing this option shall still be responsible for removal/disposal of excess material and agree that no additional compensation for reclamation or related items (lowering/plating structures, etc.) will be made. As the Town considers this option to be the Contractor's means and methods, pavement reclamation items are not included and the original pay Item 120.1, Unclassified Excavation and quantity is maintained.
