I walked 40 Beach this AM to look closely at buildings and CC.

I noted the following in the shelter shack on the Crosby's side..see attached photos:

- 1. Huge amount of rot on weather shack at the bottom of the shack which provides support to hold up the shack. Window buttressed by wood supports.
- 2. Graffiti that needs to be removed.
- 3. Someone dumped an antique chair in the shack that looks like refuse. The MBTA needs ti provide a bench.

I called this in to the MBTA Maintenance folks. The MBTA can do better at our train station.

On the other side, the steel beams holding up the long shelter also has lots of rust at the bottom...that's not a good sign either.

If the MBTA doesn't do basic maintenance on the shack, then ask them to remove it. It could be a safety issue and is certainly an eyesore with our MBTS name on th side of it. Unacceptable.

I doubt the MBTA will have any money to elevate the tracks that the CZM folks project will flood along the Rockport line before arriving to MBTS. The TF needs the mitigation plan for the rails and their maintenance plans for stations, especially in flood prone areas. It's all interrelated. Our MBTA zoning is predicated on what the MBTA can, should, and will do.
